

**Report of Crimes – 24<sup>th</sup> August 2021 on Edinburgh High Street and a Report of Alleged  
Long Term Fraud by Judges, Advocates and Others.**

*The Incident at the Edinburgh Festival*

1. I work for the charity the Fair Trial Project (No. SCO48283). We are currently running a campaign for the release of prisoner 14704, James Casey. We have a short documentary online at this year's Edinburgh Fringe.
2. I went to Edinburgh on the 24<sup>th</sup> of August 2021 to distribute some leaflets advertising the documentary. Around 13:30 I had just finished leafletting on High Street. I was taking photos of the banner I had put up when a lady approached me and asked if the 'James Casey is innocent' banner is mine (I had put the banner on an unused, boarded up building). I said it was. She then said 'sorry, but you have to take it down as it isn't licensed.' I said that I was just about to take it down (I had planned to go to the Grassmarket). She walked away and said, 'I'll get someone that will make you take it down.'
3. I was concerned. I folded up the banner and walked towards St Giles Cathedral. I noticed a lot of security with vests had now appeared. I thought, and it looked like they were looking for me. I was now more concerned. I stood next to St Giles Cathedral and tried to disappear into the background and calm down. I drank some water.
4. Next, two police officers came up and one asked if they could have a chat. They said that a colleague had informed them 'I was doing something with a banner.'
5. I asked if I was a suspect. I was told no. The Officers numbers are 669 and 990. The Officers then went on a fishing expedition asking me what I was doing in Edinburgh, where I was from etc. I contend that it is unlawful to question someone for no reason. It is also embarrassing to be approached by two uniformed police officers on the High Street in Edinburgh.

6. I said that I didn't want to answer any questions and asked for a senior officer as I wished to make some complaints.
7. My complaints were that a) I had been 'attacked' by their colleague (but I didn't go into any details with the two officers); and b) I wished to make complaints about them.
8. The two officers kept on asking what the complaints about them were. I kept on saying that I would tell the senior officer.
9. The senior officer didn't arrive. I asked if I was under arrest. Was told no, so I left. Rather than handing out more leaflets publicising the documentary and enjoying an Edinburgh evening, I went home. I was very concerned about what had happened and about reprisals.
10. I have complaints of criminality to make against officers 669 and 990 and the lady who complained to the police about me (and possibly sent 'security' looking for me).
11. I also wish to make criminal complaints that concern the underlying subject-matter of my charity's documentary and web-site (<https://fairtrialproject.org/>) and arise from the facts that I have set out above.
12. Before making the complaints, I will first set out an introduction that will show why no one in Scotland has ever had a fair trial. This is due to there not being an independent and impartial judiciary available to hear civil and criminal cases. If this contention is correct and no independent and impartial judiciary has ever existed, then it means, amongst other things, that the police have no authority to arrest or detain people. All actions of the police, including investigation, arrest and detention, are criminally unlawful.
13. The complaints I will make against the judges, advocates and solicitors pertain to a massive fraud committed for over a hundred years on the people of Scotland. All the senior judges sitting in the High Court and Court of Session, close to where I claim I was unlawfully questioned, are involved. All Lord Advocates have committed massive frauds on the Scottish People. People are in jail and have done long sentences without getting a fair trial. Innocent people are in jail.

## Introduction

### *Criminal Cases*

14. No one in Scotland has ever received a fair trial. This is due to three principal issues. First, the advocates who act as representatives have personal, financial and business links to the Scottish judges. Second, Scottish judges have conflicts of interest. Third, Scottish judges have been involved in advising the Scottish Government on legislation (the best example of this is the Carloway review where Lord Carloway (now the Lord President) was commissioned by the Scottish Government to review criminal law and procedure).

### *Civil Cases*

15. In civil cases, due principally to the three issues briefly outlined above, no one has ever had a hearing decided by a judge who is independent and unbiased. All advocates, lawyers and court staff know of the issues affecting the judge's independence and impartiality and do not inform their clients of this. Therefore, it is civil and criminal fraud to receive money for running unlawful hearings where the judges are not independent and impartial (Independence and impartiality are crucial components of a fair trial or hearing).

### *Papers on the web-site of the Fair Trial Project*

16. The web-site of the Fair Trial Project (<https://fairtrialproject.org/>) has the following papers that a) explain why no one can receive a fair trial; b) show why there has never been an independent and impartial judiciary in Scotland; and c) set out the criminality of the judges and legal profession in detail.

17. Why the Faculty of Advocates is a criminal organisation (<https://fairtrialproject.org/why-the-faculty-of-advocates-is-a-criminal-organisation/>). Financial and other links exist between members of the Faculty and Scotland's judges. No judge or advocate has ever disclosed these links. This paper will show that disclosure is necessary and that the lack of disclosure is, amongst other things, criminal and civil fraud. This paper also briefly covers the Carloway Review and the resulting criminality.

18. The control of the Scottish Courts and Tribunals Service by the judges is a conflict of interest. It is covered here: <https://fairtrialproject.org/judges-with-a-conflict-of-interest/>
19. The problem with the Lord Advocate's wife being a judge (now the Lord Advocate's husband) and the resultant criminality. <https://fairtrialproject.org/the-lord-advocates-wife/>
20. Open Justice (<https://fairtrialproject.org/open-justice/>). This paper explains that it is unlawful, in the criminal and civil sense, to exclude the public from the courts.
21. I will now set out the complaints I wish to make.

#### *Complaints concerning the afternoon of the 24<sup>th</sup> of August*

22. Officers 669 and 990 had no reason or authority to approach me. I wasn't a suspect, I wasn't under arrest. So, why approach me?
23. I was so concerned about this interaction that I cut my working visit to Edinburgh short.
24. I wish to complain that the approach by the officers was threatening and abusive. I wish this complaint to be investigated as a criminal offence.
25. I wish to make the complaint that all actions of the police are threatening and abusive and require the police to stand down while this is investigated.
26. I wish to complain that the actions of the lady who possibly reported me to security and the police be investigated. I claim this was a) assault; and b) maliciously wasting police time.
27. Please note that nothing can be done with officers 669 and 990 as they too cannot receive a fair trial. This also applies to the lady who complained about me. Therefore, nothing can be done to anyone, as no independent and impartial tribunal exists to decide whether people are guilty of crimes. It is very important that these alleged crimes, and the ones I am going on to make, are registered.

#### *Hate crimes*

28. I wish these incidents to be recorded as hate crimes. I am a 58-year-old male and an unmarried father.

29. Please ask the hate crime department to contact me via email. Once contact is made, I will explain why the alleged crimes on the 24<sup>th</sup> and many, many others must be recorded as hate crimes.

*Complaints against the Scottish judges, Advocates and Solicitors*

30. I am complaining against all Scottish judges. The complaint is that they have failed to disclose a) their financial, personal and business links to the representatives appearing in front of them; b) their many conflicts of interest; c) their involvement in legislating with the Scottish Government and Parliament; and d) their lack of independence from the Scottish Government. Disclosure is necessary and a failure to disclose is criminal fraud.

31. All judges have a duty to take action when they realise other judges are not independent and impartial. They have completely failed in this duty.

32. Please send me a crime reference number and inform me of how this complaint will be investigated.

*Complaints against the advocates and solicitors*

33. I am making a complaining against all advocates and solicitors. The complaint is that they have, failed to disclose a) their financial, personal and business links to the judges that they appear in front of; b) that the judges have many conflicts of interest; c) the judges and their own involvement in legislating with the Scottish Government and Parliament; and d) the judges lack of independence from the Scottish Government. Disclosure is necessary and a failure to disclose is criminal fraud.

34. Note that advocates and solicitors have a duty to disclose to their clients and the court.

*Complaints about the Lord Advocate and the Scottish Ministers.*

35. I am making a complaining against the Lord Advocate. The complaint is that the present and past Lord Advocates have failed to disclose a) their financial, personal and business links to the judges that decide the trials and cases they bring or appear in; b) that the judges have many conflicts of interest; c) the judges' involvement in legislating with the Scottish Government and Parliament; and d) the judges' lack of independence from the Scottish Government and Parliament. Disclosure is necessary and a failure to disclose is criminal fraud.

36. Note that the Lord Advocate is a Scottish Minister and is responsible for all criminal prosecutions in Scotland.
